1. Goals

The following goals are pursued by the Swiss CMA League:

- An attractive match calendar in Switzerland
- A common platform and an encouragement to organize and participate in successful matches
- · A high quality of the matches
- · An overall ranking for the whole year

2. Participants and Registration

The league matches are open to all shooters with a valid CMA license. The data available on cmasport.com is the relevant information source. The Match Directors can check the eligibility of the participants for their matches.

Additional participation criteria or restrictions are not allowed.

The match announcements and registrations are done on practiscore.com on a first come first served basis. The registration period has to start immediately after publication and should not end earlier than one week before the match (unless the match is fully booked).

Privileged registration terms or match fee reductions for selected participants is not allowed, except for match staff and/or CMA officials.

3. Matches

The matches will be held under the current CMA rules.

The matches can be organized by the participating clubs and institutions. They are centrally approved and coordinated. A club or institution can take ownership for several matches.

A squad can have a maximum size of 15 shooters. Smaller squads are welcome.

Safety Officers can either be static on a stage or moving with a squad.

The organizing clubs must be registered CMA clubs. The data available on cma-sport.com is the relevant information source.

The match dates will be set centrally in agreement with the organizers considering the overall planning.

League matches can be of Level 1 or higher. They can have additional significance such as club championship or national championship.

The match scoring and ranking has to be done with practiscore. The results have to be uploaded to practiscore immediately after the match has ended. After the match award ceremony, the results cannot be changed anymore except with justification and central approval.



If a match cannot be performed as planned due to force majeure, a solution will be defined centrally in collaboration with the organizers; for example postponement, cancellation, adaption of the scoring, and so on. If applicable, refunding the match fees is the responsibility of the organizers.

3.1. Handgun Matches

There will be 5 handgun matches distributed throughout the calendar year.

The matches must offer a minimum capacity for 15 shooters.

A handgun match must have a minimum of 6 stages and a total round count of minimum 120. Larger matches are welcome.

3.2. Two-Gun Matches

There will be 5 two-gun matches distributed throughout the calendar year.

The matches must offer a minimum capacity for 15 shooters.

A two-gun match must have a minimum of 6 stages and a total of minimum 120 rounds. The dominant firearm is the rifle.

Larger matches are welcome.

4. Stages

All stage descriptions must follow the template and will be published in pdf format. Other formats are not allowed.

The stages must be centrally approved before the match. The MD is responsible to obtain the approval in due time. The stages must be completed and approved latest two weeks before the match date. A match with one or several stages that are not approved will not be included in the overall ranking at all. Approvals after the match has taken place are not allowed.

The approved stages are to be published and made available to the shooters no later than 1 week before the match date in a suitable manner, for example on practiscore, on facebook, on the club homepage and so on.

5. Scoring & Ranking

Match scoring and ranking will be done according to the current CMA rules.

There will be the following overall rankings:

- Handgun per division
- Two-Gun per division

All valid match results will be included in the overall rankings. Shooters included in a match ranking are automatically included in the overall ranking.

The overall rankings will be done for all handgun and two-gun divisions respectively. There will be no separate category rankings.



A competitor can be ranked in several handgun and/or two-gun divisions per season. However, points cannot be transferred from one to another division.

With each successful match participation, a shooter can collect points and bonuses. This ranking system nicely balances absolute and relative performance as well as diligent participation.

Points: The points factor a shooters rank and the total number of ranked competitors. The more people are behind a particular shooter, the more points he or she will earn.

Points per match and division = (number of shooters + 1) - (attained rank)

Only ranked shooters count for the number of shooters. DNFs, No Shows and DQs are not counted.

Podium-Bonus: The podium-bonus rewards a position on the podium irrespective of the total number of ranked shooters.

Podium-Bonus per match and division:

Rank 1 = 5

Rank 2 = 3

Rank 3 = 2

Match-Bonus: The match-bonus rewards diligent participation in the matches, irrespective of rank or total number of ranked shooters.

Match-Bonus per year:

3 or more matches = 5

Scratch Result: The 4 (or less) best match results, calculated using the points and the ranking-bonus are summarized for the overall result. The match-bonus is then added based on all successfully attended matches.

Match Result = points + podium-bonus

Overall result per shooter = (sum of the best 4 match results) + match-bonus

6. Match-Fees and Other Fees

The clubs can define match-fees. The match-fee per participant and match cannot be more than CHF 100.- and has to be of the same amount for all participants. Higher match fees have to be justified and approved in advance.

The MD, active SOs and the league organizers can participate for free.

7. Trophies

At the end of the season, the following trophies or medals will be awarded by SwissAAA:

- For each handgun division with 5 or more shooters: Rank 1-3
- For each rifle division with 5 or more shooters: Rank 1-3



Additional prices, such as for example sponsored gifts are allowed upon agreement. The organizers are encouraged to award their own trophies or medals at a match.

8. Organization

The central coordination of the league is done by SwissAAA. The official league website is www.swissaaa.org

The participating organizers nominate a responsible person for the league. This person acts as a contact for the league.

The overall ranking will be done centrally. All organizers have to refer to that ranking. Individual match rankings can be done and published.

The year overall award ceremony is performed at the end of the season, if possible at the last league match of the year.

9. Communication

All communication concerning league matches has to include the term "Swiss CMA League", "CMA Liga Schweiz" or "Ligue CMA Suisse".

Match publication and administration is done with practiscore.com. Other registration or administration systems are not allowed.

All matches are published on www.swissaaa.org, on www.cma-sport.com and in the facebook group CMA Sport. The organizers can advertise their matches additionally using other platforms and media.

The current and final rankings are exclusively maintained on www.swissaaa.org.

Logos, graphics, lettering styles and similar things of the league are defined and maintained centrally. Only those are to be used referring to the league.

All sponsoring has to follow the CMA sponsoring concept.

10. Disciplinary Measures and Complaints

Violation of the rules can be punished with all penalties according to the CMA rules up to the exclusion from CMA and the league. Match penalties can be imposed by a SO and confirmed by the MD. Exclusions from the league can only be decided centrally on report of a MD.

If an institution is conducting matches in an inappropriate way, it can be excluded from the league. This applies for any future conducting of matches by the organizer but has no influence on the future participation of individual club members.

Complaints can be filed by any participant, club, SO or MD directly to the central administration. The central decisions are always final and cannot be appealed or escalated further.
